Historically structural inequities have placed some of our children in situations of greater stress, trauma, and violence. Thus, traumainformed practice that heals kids exemplifies equitable practice. I want to highlight <u>Resilient Southern Illinois</u>, one partnership that is supporting this healing by addressing students' unique needs. The innovative collaboration includes the Poshard Foundation for Abused Children, Illinois Education Association and <u>Partnership for Resilience</u>, and more than 15 school districts in Southern Illinois. Educators and staff in participating schools are provided with ongoing training and resources as they build relationships to support students experiencing trauma and nurture students' social-emotional development.

Resilient Southern Illinois speaks to the necessity of being in deeper relationships to care for the whole child, whole school, and whole community. Children are not preordained to be defined by their trauma. Mitigating buffers and protective factors can help children heal and overcome any ACEs score. People read over trauma-informed practice and do not understand how fundamentally important it is. Trauma-informed classrooms are places where all children are getting their needs met. We firmly believe that trauma-informed practice benefits every single child *and adult* in the classroom and in the school.

Our alternative and safe schools are partnering with Resilient Southern Illinois, where our staff participates in training and the implementation of trauma informed practices. We are transforming our schools with the knowledge and best practices to meet the social emotional and educational needs to best support our students.

Beginning March 31, 2020 ECHO Alternative School, STARQuest Academy Regional Safe School, and ECHO Juvenile Detention Center began implementation of Remote Learning Days due to COVID 19. Remote learning continued for the remainder for the 20-21 school year.

Regional Safe School Cooperative Education Program (RSSCEP)

As an extension of the regional safe school program located in Metropolis, we were able to provide an alternative cooperative education program for student 16 and older with paid work experience; provide for course credit- a minimum of 200 minutes of instruction per week on general and specific topics related to careers and employment; provide an individualized optional education plan (IOEP) for each student; work closely with the employer- school guidance personnel- teachers- parents- and others; provide a suggested minimum 10 hours per week of work experience; a suggested 20 hour per week maximum but only with the permission of the teacher-coordinator and employer; provide work experience training in period of regular employment; establish procedures for cooperation with employment agencies- labor groups- employers- and other community agencies in identifying suitable training sites; and provide high school credit upon successful completion of the cooperative education program.

With 10 students enrolled in the program 7 of the students completed high school credit and successfully completed the program. 3 of these students are continuing to work in constructions and landscaping.

IL Empower

Regional Office of Education #21 is an Illinois Empower Learning Partner. IL-EMPOWER is school improvement. Schools, districts, partners, and the state work collaboratively to promote shifts in practice based on each school's improvement needs. IL Empower builds capacity in the areas of Governance & Management, Curriculum & Instruction, and Climate & Culture. Consultants through ROE #21 work with districts to provide individualized professional development to our underperforming districts. The following differentiated sessions have taken place throughout ROE #21.

Community Prevention Resources

(CPR) is a comprehensive grant-funded program by the Illinois Department of Human Services (DHS) to provide substance abuse prevention services to communities in Franklin and Saline counties. The Regional Office of Education #21 serves as the administrative agent for the program, and funds two full-time employees: Kate West, Director & Samantha Lampley, Prevention Specialist.



CPR Programs and Deliverables:

Youth Prevention Education: Project Alert

A skill-based curriculum for teens that motivates them against drug use and equips students with skills and strategies that they can use to resist drugs.

- 7th Grade: 12 Core Lessons & 8th Grade: 4 Booster Lessons
- Lessons completed

Youth Prevention Education: Generation RX

"My Generation Rx" includes resources designed to educate teens about the importance of using medications safely, as well as teaching teens key skills to turn down invitations to misuse and positive alternatives to cope with the demands of life.

Youth Advisory Council (YAC)

Student leadership group interested in making a positive impact in their community. Members of this group expect to participate in a National Prevention Week project, the youth-focused communication campaign (Use Your CUBE), and other prevention activities.

National Prevention Week (NPW)

National Prevention Week is an annual health observance dedicated to increasing public awareness of, and action around, mental and/or substance use disorders. These projects create awareness regarding Preventing Underage Drinking and Alcohol Misuse and Preventing Prescription and Opioid Drug Misuse.

Communication Campaigns (In-House): Use Your Cube and Elephant Is In The Room

Youth and Parent communication campaigns that focus on the contributing factors of alcohol use are implemented in West Frankfort Central Junior High School, Eldorado Middle School, and Harrisburg Middle school.

• Alternative programming was used to accommodate the unusual circumstances - moved interactive programming online.

Communication Campaign (State-Provided): Guard & Discard

Communication campaign that raises awareness regarding the safe use, storage, and disposal of prescription drugs.

National Take Back Day

Promote the DEA's National Take Back Day, which provides an opportunity for safe disposal of unused medicines in an effort to prevent the misuse and abuse of medicine, and to protect against environmental hazards of improper disposal.

- April 25, 2020 Event canceled
- Promoted permanent DEA approved drug take-back locations in place of the national event.

Illinois Youth Survey (IYS)

The IYS has been used to survey the health and social indicators of Illinois youth since 1993, and creates individualized, easy-touse reports that you can use to assess school needs, track progress towards your school's physical, social and mental health goals, and evaluate student support services.

- 8th, 10th, & 12th Graders are surveyed every 2 years
- Surveys usually open January-May 2020, but closed temporarily due to school closures because of the COVID-19 pandemic. (March 17th-TBD)
- 100% of schools in Saline and Franklin counties were registered for the survey prior to March 17. Most of the schools had already surveyed students, but six schools were scheduled to survey during or after state testing.

Resource Guide

Maintain a guide that identifies area substance abuse disorder treatment and human service organizations. *Created in partnership with the Southern Illinois Continuum of Care and the McKinney-Vento Homeless Program (Area 6).*



Franklin County Regional Delivery System for Career and Technical Education (FCRDS-CTE) Education for Employment #525

FJMW Regional Office of Education serves as Fiscal Agent for the Franklin County CTE cooperative. The programs are funded by Federal Perkins Grant and CTEI Grant. Cooperating school districts include Benton Consolidated H.S., Christopher H.S., Frankfort Community H.S., Sesser-Valier H.S., Thompsonville H.S., and Zeigler-Royalton H.S.

Mr._George Hopkins serves as the Director of the FCRDS, whose IL State Board of Education identification is <u>Education for Employment # 525. (EFE 525)</u>. As of 11-6-19, Mrs. Jan Farkas serves as Administrative Assistant.

The FCRDS-CTE is governed by the FCRDS Board of Control, which consists of Franklin County school superintendents and the ROE 21 Regional Superintendent. ROE 21 serves as the entity's fiscal agent.

FCRDS-CTE operates two "Regional" CTE classes available to Franklin County students:



--Don Wilburn is in his second year as the CTE Instructor for FCRDS Building Trades Regional Class serving students in the 2018-19 school year from Christopher, Sesser, and Benton. Projects of note: Construction of walls and soffits for a non-profit; on-site walls and ceilings for Ewing Government Offices; 12x20 storage facility.

--Lee Messersmith is the teacher/facilitator of Entrepreneurial Development, Growth and Education (EDGE) Class (the study of entrepreneurship). This class is now meeting (2019-2020 school year) in the MINCON Buildings, formerly Bombardier, in Benton Industrial Park.

The Franklin County Regional Delivery System supports programs in Agricultural Education, Business, Marketing, and Computer Education, Family and Consumer Sciences, Technology and Engineering, Health Science Technology.

Programs are supported through state and federal grants designed to supplement CTE programs. Allowable expenditures for these grants include: Instructional materials, instructional equipment (capital outlay); partial salary payments to districts to help ensure affordability of qualified instruction; tutorial services; and improvement of instruction activities.

The Franklin County Regional Delivery System for CTE funds also provide supplemental funds for (K-8) Career Exploration programs at Akin CCSD 91, Benton CCSD 47, Christopher CUSD 99, Ewing-Northern CCSD 115, Frankfort CUSD 168, Sesser-Valier CUSD 196, Thompsonville CUSD 174, and Zeigler-Royalton CUSD 188.

FCRDS also conducts Workshops and hosts ISBE-sponsored professional development for educators in Franklin and Jefferson Counties per the CTE/Perkins Programs of Study requirements. FCRDS for CTE prepares and submits to Illinois State Board of Education various reports regarding program operation, assessment, and improvement.

As mentioned above, in addition to its funding support of all CTE classes in Franklin County high schools, FCRDS operates/supports two Regional CTE classes that are available to all students in Franklin County: Construction Trades Class and Entrepreneur Class (Entrepreneurial Development, Growth, and Education (EDGE). Brief summaries follow:

Construction Trades Class

Over the past three years the students have built and sold a Tiny House and built items for the Benton Library Garden, including a 12'x16' storage facility. During

the school year of 2018-19, students, under direction of instructor Don Wilburn, have constructed walls and soffits for non-profit agency, walls and ceilings for offices at new Ewing Village Office, and a 12'x 20' storage facility, among other items. Now in its fourth year of existence, this year's Construction Trades class was the most successful and productive. In school year 2019-20, the class has assisted Habitat for Humanity by providing labor for that organization's most recent new house, building front porch, interior walls, running electrical wire, etc.

Entrepreneurial (EDGE) Class

This entrepreneurial class acquaints students with knowledge and skills necessary to own and operate their own businesses. Topics of the class include economics, marketing principles and strategies, human relations and psychology, business and labor law, legal rights and responsibilities of business ownership, financial planning and accounting, and business communication. Students are required to plan and execute a business plan and operate a bona-fide business.

Per IL St Bd of Education rules, Intergovernmental Coop Agreement regulations, and Board of Control authorization, the CTE Director publishes notice of Joint Agreement Budget on review 30 days in advance of a public hearing that is conducted in August of each fiscal year at Regional Office of Education 21.

ALLOCATIONS FOR FISCAL YEAR 2020

Fiscal Year 2020 CTEI Grant Allocation is \$242,000. The FY 20 CTEI Grant has been written, submitted, and approved by ISBE. In <u>May, 2020, FCRDS was able to amend its budget an capture an additional \$10,554 for Franklin County CTE programs</u>, bringing the total for FY 20 CTEI Grant to \$252,554. As of 6-30-20, \$240,000 has been received from ISBE.

Fiscal Year 2020 Perkins Grant Allocation is \$86,526. This grant has also been prepared, submitted, and approved by ISBE. As of 6-30-20, all funds have been received in reimbursement from ISBE, and the FY 2020 Perkins Grant was finalized and closed as of this date.


