The Multifunction School Activity Bus (MFSAB) can be used for curriculum related events for grades 9-12 or a student in any grade K through 12 with an Individualized Education Plan (IEP) with a staff to student ratio of 1 to 5 ONLY at the following organizations: Acacia Academy, Alexander Leigh, Marklund, Helping Hands Center, Connections Organization, Soaring Eagle Academy or New Horizon Academy. (Home to school and school to home transportation is prohibited) (625 ILCS 5/11-1414.1)

• Curriculum related trips include to and from school, from one school to another, or for a curriculum-related event or field trip. If attendance at the event is a requirement for a class, the trip is curriculum related.

• School districts can claim depreciation for the Multifunction School Activity Bus (MFSAB, manufactured for the purpose of transporting 11 or more passengers [625 ILCS 5/1-148.3a-5]) Districts can depreciate the entire cost of the bus over a five-year period (20% per year) on the Pupil Transportation Claim Reimbursement System (PTCRS).
